Pursuant to the Circular No. 14/2020 dated April 08, 2020, Circular No. 17/2020 dated April 13,2020 and Circular No. 20/2020 dated May 5th, 2020 , clarification circular No. 02/2021 dated January 13th, 2021 and General Circular 3/2022 dated May 5, 2022 and General Circular10/2022 dated December 28 2022 issued by the Ministry of Corporate Affairs(collectively referred to as “MCA Circulars”), permitted the holding of Annual General Meeting (AGM) through VC/ OAVM, without physical presence of the member at common Venue. Hence, Members can attend and participate in the ensuing AGM though VC/OAVM.
2. The members have the option to participate in the meeting either in person or through Video Conferencing (VC)/Other Audio-Visual Means (OAVM).

Smt. S. Karpagam was appointed as an Additional Director in the Board Meeting held on 4th October, 2022 in accordance with the provisions of Section 152, 161, 196, 203 and Rule 8 of the Companies (Appointment & Remuneration of Managerial Personnel) Rules 2014 read with Schedule V of the Companies Act, 2013, and the Articles of Association of the Company. Pursuant to Section 161 of the Companies Act, 2013, the above director can hold office only up to the date of the ensuing Annual General Meeting of the Company. Further, in the same meeting i.e. meeting held on 4th October, 2022 the Board appointed Smt. S. Karpagam as the Managing Director of the Company, with immediate effect, for a period of one year w.e.f. 4th October, 2022 subject to the approval of the shareholders.

Smt. S. Karpagam is not disqualified from being appointed as Director in terms of Section 164 of Companies Act, 2013 and has given her consent to act as Director. The Nomination & Remuneration Committee and the Board have completed a formal annual evaluation of her performance based on the evaluation criteria as set in the Nomination and Remuneration Policy of the Company.

The Board is of the opinion that the appointment and presence of Smt. S. Karpagam on the Board as the Managing Director will be desirable, beneficial and in the best interest of the Company. The Board recommends the resolution set out in item no. 4 of the accompanying Notice for approval and adoption of the Members.

2. Business Outlook and Performance

Business Environment for NBFC

Non-banking financial companies (NBFCs), public and private banks, and financial institutions form the four broad constituents of the credit ecosystem of the Indian financial sector, with NBFCs being a key pillar therein. Over the past few decades, NBFCs have navigated several storms.

After several challenging years, fiscal 2023 has brought growth back into focus for NBFCs. To be sure, NBFCs have demonstrated an innovative and resilient streak over the years, adapting efficiently, even during the Covid-19 pandemic, to an evolving credit landscape. NBFCs are stronger and more resilient today, and better positioned in almost all operationally critical parameters. Overall, the sector has much stronger balance sheets today.

After weathering countless challenges over the past three fiscals, exacerbated by the Covid-19 pandemic, fiscal 2023 has brought growth back into focus for NBFC. This is expected to continue into fiscal 2024, with assets under management (AUM) of NBFCs projected to increase 13-14% vis-a-vis single-digit growth over the past three fiscals. The acceleration will ride on improving economic activity, strengthened balance sheet buffers, and better asset quality metrics.

Over the past three fiscals, NBFCs largely focused on liquidity, capital and provisioning buffer. These, combined with the consistent improvement in economic activity, have put the sector in a better position today to capitalize on growth opportunities.

Competition from banks and rising interest rates are the key challenges

While NBFCs are relatively well placed today as compared to the past few years, though competition from Banks and the rising interest rate scenario had posed challenges. Competition from banks has intensified, especially in loan product.

Digital lending - On the edge of reorientation

Digital lending in India today is on the edge of reorientation, as the segment navigates crosscurrents of increasing regulatory supervision amid continuing influx of digital lenders. Providing the much needed support to the ecosystem is enhanced mobile network coverage, rising smartphone usage, and increasing availability of formal data. Indeed, the space has the potential to change the anatomy of the Indian financial ecosystem.

Growth of digital adoption in India is reflected in the rise in the RBI digital penetration index from 100 in March 2018 to almost 350 in March 2023 (Source : Crisil)

Digital lending guidelines leading to reorientation of business models

While the regulatory regime is still evolving, the RBI has announced digital lending guidelines this fiscal, which could alter the way of doing business, increase operating expenses and change documentation models. The guidelines on disbursements and collections being directly routed

between the bank account of the lender and the borrower will impact business models of some NBFCs. Players now have to come out with a key fact statement as per RBI guidelines and disclose the annual percentage rate (APR) upfront. While charges used to be disclosed to borrowers earlier too, the new guidelines could impact incremental business as borrowers will now be able to see their total annual costs upfront and compare them with the alternatives. The introduction of the cooling off period of 3 days without any prepayment penalty may affect retention of customers, which is crucial, given the short tenure of loans and the relatively high cost of acquisition for NBFCs.

Product wise performance

ISFL presently has two main products under its portfolio basket viz Loan against shares and Loan against mutual funds. ISFL is focusing on online digital mode through Software as a Service (SaaS) models. It may be noted that there were no slippages to NPA during FY 22-23 and all Loan accounts in this fiscal are Standard Assets.

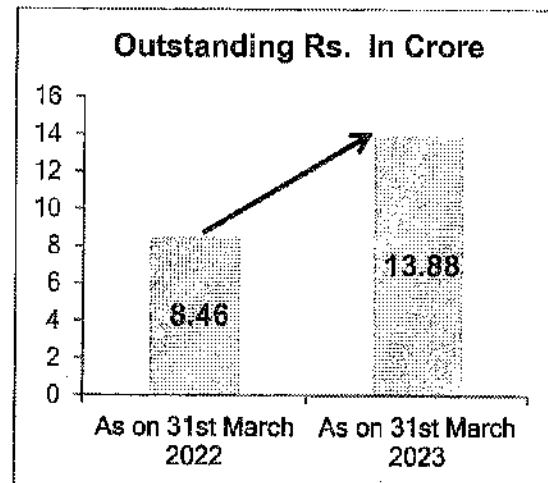
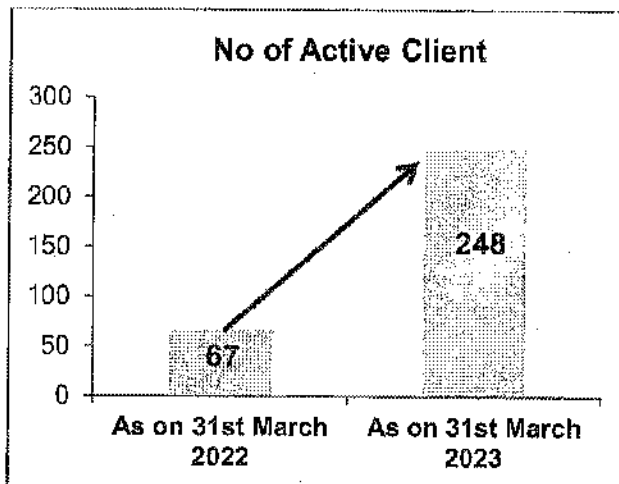
Portfolio improvement

Financial performance

Revenue from the operations of the Company has increased marginally from Rs 102.67 lakhs in FY 21-22 to Rs 108.80 lakhs in FY22-23, mainly due to increase in Interest on loans from Rs 102.49 lakhs to Rs 106.55 lakhs in FY 22-23. However, other Income showed a reduction from Rs 141.69 lakhs in FY 21-22 to Rs 126.65 lakhs, primarily on account of lesser profit on sale of Investment (Rs 62.14 lakhs vis Rs 89.25 lakhs last year).

Even though the employee expenses showed remarkable reduction from Rs 63.27 lakhs in FY 21-22 to Rs 43.04 lakhs in FY 22-23 and other expenses showed only a marginal increase over last year attributable to higher impairment on account of Provisions on Standard Assets (Rs 11.43 lakhs in FY 2022-23 vs Rs (-)2.83 lakhs in FY 21-22),the total expenses during FY 22-23 were however hovering around the same level of Rs. 201-202 lakhs as in last year.

Lesser Total Income and almost same level of Total Expenses in FY 22-23 contributed to a decrease in Profit before Tax to Rs 32.91 lakhs in FY 22-23 from Rs 43.19 lakhs in FY 21-22 .Profit After Tax however showed an increase to Rs 39.03 lakhs in FY 22-23 from Rs 30.63 lakhs in FY 21-22.

Material Developments in Human Resources/ Industrial Relations front, including number of employees:

The company has adequate human resources commensurate to the size of the business. As on March 31st, 2023, there were 5 employees on rolls of the company. It further utilized the services of 3 employees who were on deputation from its parent company- IFIN.

3. Dividend

No dividend is being recommended by the Directors for the year ended March 31st, 2023.

4. Transfer To Reserves

For the FY 2022-23, the Company had reported a profit after tax of Rs. 39.03 lakh and Rs. 7.81 Lakh was transferred to Statutory Reserve as on March 31st, 2023.

5. Directors and Key Managerial Personnel**Changes in Directors and KMP during the year 2022-23:**

- i) Mr. Karra Visweswar Rao (DIN: 08111685) who was appointed as Managing Director of the Company with effect from 01.07.2021, ceased to be associated with the company with effect from 04.10.2022 on account of withdrawal of his nomination by IFCI Limited.
- ii) Ms. S Karpagam (DIN: 09755388) was appointed as an Additional Director and designated as Managing Director of the company with effect from 04.10.2022.
- iii) Mr. Ramesh NGS who retired by rotation at the 33rd Annual General Meeting held on September 29th, 2022, was re-appointed as the Director of the Company. He was ceased to be associated with the Company with effect from 17.04.2023 on account of his resignation.
- iv) Mr. Siddharth Dwivedi, Company Secretary tendered his resignation and was relieved from his services with effect from 15.06.2022.
- v) Ms Sanjana Chhabra, Company Secretary had been appointed as Company Secretary with effect from 31.10.2022. She also tendered her resignation as Company Secretary and was relieved of her services with effect from 26.07.2023.
- vi) Mr. Ramkurmar Srinivasan (DIN: 01175498), director will retire by rotation at the conclusion of the ensuing Annual General Meeting and being eligible has offered himself for re-appointment.

Engaged our team to review management's approach for calculating ECL and assess the





impairment allowance which has a significant impact on the financial statements.

Management is required to determine the expected credit loss that may occur over either a 12-month period or the remaining life of an asset, depending on the categorisation of the individual asset.

The key areas of judgement include:

1. Categorisation of loans in Stage 1, 2 and 3 based on identification of:
 - (a) exposures with significant increase in credit risk ('SICR') since their origination and
 - (b) Individually impaired / default exposures.
2. Techniques used to determine Loss Given Default ('LGD') and Probability of Default ('PD') to calculate an ECL based on past experience.
3. The impact of different future macroeconomic conditions in the determination of ECL.

These judgements required the models to be reassessed to measure the ECL. Given the size of loan portfolio relative to the balance sheet and the impact of impairment allowance on the financial statements, we have considered this as a key audit matter.

key assumptions i.e., probability of default (PD) and loss given default (LGD) used to determine ECL.

3. Tested the periods considered for capturing underlying data as base to PD and LGD calculations are in line with Company's recent experience of past observed periods.
4. Performing test of details over calculation of ECL for assessing the correctness of the same.
5. Assessed whether the disclosures on key judgements, assumptions and quantitative data with respect to impairment loss allowance in the financial statements are appropriate and sufficient.

As a result of the above audit procedure, no material differences were noted.

In preparing the financial statements, the Board of Directors is responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Company or to cease operations, or has no realistic alternative but to do so.

The Board of Directors are also responsible for overseeing the Company's financial reporting process.

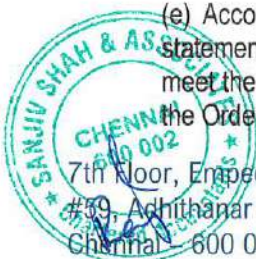

A. Company Background

IFIN Securities Finance Limited ("the Company") is a non-deposit taking Non-Banking Financial Services Company- (NBFC-LC) incorporated and domiciled in India and governed by the Companies Act, 2013 ("Act"). It is registered with the Reserve Bank of India as a Loan Company. The name of the company was changed to IFIN Securities Finance Limited vide Certificate of Registration dated 26th August 2013 from erstwhile name of Narayan Sriram Investments Private Limited. The Company's registered office is situated at Continental Chambers, 3rd Floor, 142, Mahatma Gandhi Road, Nungambakkam, Chennai 600034 Tamil Nadu, India.

The company is primarily engaged in the business of providing loans against shares, margin funding and Mutual Funds.

B. Significant Accounting Policies

A. Basis of preparation and presentation

These financial statements have been prepared in accordance with the Indian Accounting Standards ('Ind AS') as notified by Ministry of Corporate Affairs ('MCA') under Section 133 of the Companies Act, 2013 ('Act') read with the Companies (Indian Accounting Standards) Rules, 2015, as amended and other relevant provisions of the Act. The Company has uniformly applied the accounting policies for all the periods presented in these financial statements.

The financial statements have been prepared on the historical cost basis except for certain financial instruments that are measured at fair values at the end of each reporting period, as explained in the accounting policies below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods or services. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Company takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date.

Fair value for measurement and/ or disclosure purposes in these financial statements is determined on such a basis, except for share- based payment transactions that are within the scope of Ind AS 102, leasing transactions that are within the scope of Ind AS 116.

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2, or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

The company has threshold limit for materiality based on the total amount of loans outstanding.

The financial statements for the year ended 31 March 2023 are presented in Indian Rupees and all values are rounded in Lakhs, except where otherwise indicated. The financial statements were authorised and approved for issue by the Board of Directors on May 11, 2023.

B. Use of estimates

In preparing these financial statements, management has made judgments, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. Actual results may differ from these estimates.

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised prospectively.

Judgements are made in applying accounting policies that have the most significant effect on the amounts recognised in the financial statements.

Assumptions and estimation uncertainties that have a significant risk of resulting in a material adjustment are reviewed on an ongoing basis.

C. Revenue recognition

Interest Income on Loan against shares

Interest earned on loans against shares (financial asset) is recognized based on the effective interest rate (EIR) method as per Ind AS 109 & 32, and is the rate that exactly discounts the estimated future repayments of principal and interest through the expected life of the financial asset to the gross carrying amount of a financial asset i.e the amortised cost of the financial asset, before adjusting for any credit loss allowance which are applicable for Stage 1 (Performing) and Stage 2 (Under-performing) assets. For Stage 3 (Non-performing) assets, expected interest rate is calculated on the amortized cost less expected credit loss adjustment. Refer note 22 for details on impairment.

Processing fee received by the company relating to the creation or acquisition of a financial asset is considered an integral part of the effective interest rate of a financial instrument and is treated as an adjustment to the effective interest rate or amortised uniformly over the lifetime of the financial instrument.

Interest income on margin funding

Considering the nature and complexity of margin trading, it is not possible to apply the effective interest rate method and so interest has been considered on a time proportion basis taking into account the amount outstanding and the rate applicable.

Interest income on Loan against mutual funds

Interest earned on loans against mutual funds (financial asset) is recognized based on the effective interest rate (EIR) method as per Ind AS 109 & 32, and is the rate that exactly discounts the estimated future repayments of principal and interest through the expected life of the financial asset to the gross carrying amount of a financial asset i.e the amortised cost of the financial asset, before adjusting for any credit loss allowance which are applicable for Stage 1 (Performing) and Stage 2 (Under-performing) assets. For Stage 3 (Non-performing) assets, expected interest rate is calculated on the amortized cost less expected credit loss adjustment. Refer note 22 for details on impairment.

Processing fee and other documentation charges received by the company relating to the creation or acquisition of a financial asset is considered an integral part of the effective interest rate of a financial instrument and is treated as an adjustment to the

effective interest rate or amortised uniformly over the lifetime of the financial instrument.

The interest income as per the EIR method is calculated based on the materiality level and as per the discretion of the management.

Dividend Income

Dividends are recognised in profit or loss only when

- (a) The company's right to receive payment of the dividend is established;
- (b) It is probable that the economic benefits associated with the dividend will flow to the company; and
- (c) The amount of the dividend can be measured reliably.

Interest on fixed deposits

Interest income on deposits with banks is recognized in time proportion basis taking into account the amount outstanding.

Miscellaneous income

All other income is recognized on an accrual basis, when there is no uncertainty in the ultimate realization/ collection.

D. Borrowing costs

The borrowing costs are recognised in profit or loss in the period in which they are incurred.

E. Employee benefits

(a) Defined contribution plan:

The Company's Provident Fund Scheme and other statutory funds are defined contribution plans and the company's contribution paid/payable is recognized as expense in Statement of Profit & Loss during the period in which the employee renders the related service. The company has contributed Rs.1.43 lakhs (FY 2021-22 - Rs.1.49 lakhs) to provident fund, which has been charged to Statement of Profit & Loss.

(b) Defined benefit plan

(i) Gratuity

The liability recognized in the balance sheet in respect of defined benefit gratuity plans is the present value of the defined benefit obligation at the end of the reporting period less the fair value of plan assets (if any). The cost of providing

F. Income taxes & Deferred tax

Income tax expense represents the sum of the tax currently payable and deferred tax. Current and deferred tax are recognised in profit or loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively.

Current tax is determined on taxable profits for the year chargeable to tax in accordance with the applicable tax rates and the provisions of the Income Tax Act, 1961 including other applicable tax laws that have been enacted or substantively enacted. The Company has made provision for current tax for Rs.10.13/-Lakhs during the current year.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Depreciation/ amortisation:

Depreciation is recognized so as to write off the cost of assets less their residual values over their useful lives, using the straight line method in the manner prescribed under Schedule II of the Companies Act, 2013. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, and changes if any has been accounted on a prospective basis as changes in accounting estimates. In order to maintain uniformity in accounting policies adopted by group companies, the company has changed the depreciation method from written down value to straight line.

The depreciation calculated under straight line amounted to Rs.1.77 Lakhs which has been charged to the statement of profit and loss in the current financial year.

Items of Plant, Property and Equipment is fully depreciated where the management estimates the useful life is less than 12 months and charged to the statement of profit and loss.

H. Intangible assets - Computer software

Intangible assets comprising of computer software is recognized if they are separately identifiable and the Company controls the future economic benefits arising out of them. All other expenses on intangible items are charged to the statement of profit and loss.

Amortisation:

Amortization is recognized so as to write off the cost of intangible assets less their residual values over their useful lives, using the straight-line method. I. Provisions

Expected Credit Loss (ECL)

Expected credit losses are the weighted average of credit losses with the respective risks of default occurring as the weights. Credit loss is the difference between all contractual cash flows that are due to the Company in accordance with the contract and all the cash flows that the Company expects to receive (i.e., all cash shortfalls), discounted at the original effective interest rate. The Company estimates cash flows by considering all contractual terms of the financial instrument through the expected life of those financial instruments.

The Company measures the loss allowance for the financial instruments at an amount equal to the lifetime expected credit losses if the credit risk on those financial instruments has increased significantly since initial recognition. If the credit risk on financial instruments has not increased significantly since initial recognition, the Company measures the loss allowance for those financial instruments at an amount equal to 12 month expected credit losses. The twelve months expected credit losses are portion of the lifetime cash shortfalls that will result if default occurs within 12 months after the reporting date and thus, are not cash shortfalls that are predicted beyond the 12 months.

If the Company measured loss allowance for the financial instruments at life time expected credit loss model in the previous period, but determines at the end of a

reporting period that the credit risk has not increased significantly since initial recognition due to improvement in credit quality as compared to the previous period, the Company again measures the loss allowance based on 12 month expected credit losses.

When making the assessment of whether there has been a significant increase in credit risk since initial recognition, the Company uses the change in the risk of a default occurring over the expected life of the financial instruments instead of the change in the amount of expected credit losses. To make the assessment, the Company compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and consider reasonable and supportable information, that is available without undue cost or effort, that is indicative of significant increase in credit risk since initial recognition.

The company recognizes stages for recognition of expected credit loss on financial instruments for which there has been significant increase in credit risk since initial recognition. The probability of default and loss given default have been measured using past credit history, and forward looking credit risk estimations which may include external credit ratings and credit loss experiences of other peer companies wherever applicable.
